For example, access to a local supply of aggregates is key to achieving cost effective delivery of infrastructure. Conversely, where the use and development of aggregate resources is not available, this has a fundamental effect on the ability of communities to provide for roading, building and other infrastructure requirements vital to their wellbeing.</p> <p>This submission is supported on the basis that it recognises that the use and development of natural and physical resources contributes to the social, cultural and economic wellbeing of Otago's communities, and that this is a significant resource management issue.</p> <p>Limiting this recognition to the human health and wellbeing benefits associated with access to and recreational use of natural resources is not supported as it artificially constrains the contribution of natural and physical resources to wellbeing.</p>	That the submission be allowed (in part)
