Effects on Aquatic Ecosystem

- 1) The e3Scientific (e3S) report noted that Lagarosiphon major was found in one location where a slow-moving pool had formed downstream of a willow tree. The authors of this report recognize that its scope of work was limited to a singular site visit. "A full range of biota that are present at this site may not have been seen or recorded". It is of real concern, considering the one site visit, that lagarosiphon is highly likely to exist in other locations. The potential effect that dredge and tender movements could have on spreading this invasive plant to establish in areas downstream is cause for alarm.
- 2) In total, three micro-invertebrate samples were collected providing a very small snapshot of the community in the river. Samples were collected from the river margin only. The sampling does not represent the mid-river area where dredging will occur.

In summary, we feel that there is insufficient information to determine the level of effects the dredging will have on the aquatic ecosystem.

3) We strongly support the conclusion of the Aukaha Cultural Impact Assessment. "Overall, mana whenua are concerned that the current dredging proposal perpetuates existing inequities in environmental outcomes".
