habitat enhancement and population monitoring. In order to facilitate eel passage Contact has a trap and transfer programme in place where juvenile eel (elver) are caught below the Roxburgh dam and



relocated above the Roxburgh, Clyde and Hāwea dam. We have a migratory eel fishing programme to facilitate the downstream passage. Our submission is neutral. However, we would like to know that any dredging activity in this section of the Clutha Mata-au will not undermine the integrity and outcomes of Contact's efforts to encourage elver and adult eel migration.
Contact's programme to facilitate lamprey passage through a trap and transfer is in its early stages, however our intentions are to enhance lamprey recruitment within regions of the upper Clutha in future. Again, we would like to ensure that any dredging activity in this section of the Clutha Mataau does not undermine Contact's efforts to encourage lamprey migration.
NOTE: The application notes that Authorities from both the Department of Conservation and Land Information New Zealand (LINZ) will also be required. In respect of the land subject to the application that is riverbed and administered by LINZ, Contact Energy holds an Operating Easement from the Crown to enable it to carry out activities associated with the generation of electricity. As part of the applicant obtaining the required authority for LINZ, Contact will need to provide its approval.

We are interested in the measures that will be proposed to manage the impacts of dredging activity on the migration pathways and general health of native freshwater fish species, specifically longfin eel and lamprey. We hope that any mitigation options will enhance the existing trap and transfer, consistent with the aspirations of our programme.

The closing date for serving submissions on the consent authority is the 20th working day after the date on which public or limited notification is given. If the application is subject to limited notification, the consent authority may adopt an earlier closing date for submissions once the consent authority receives responses from all affected persons.

You must serve a copy of your submission on the applicant as soon as is reasonably practicable after you have served your submission on the consent authority.

Privacy: Please note that submissions are public. Your name and submission will be included in papers that are available to the media and the public, including publication on the Council website. Your submission will only be used for the purpose of the notified resource consent process
