I am opposed to the building of such a structure at the wharf. This is far beyond a "boat shed". I have no problem with boat access by pontoon with a floating dock, etc. But I do oppose an actual structure of the size being requested. This may set a precedent for future structures along the wharf and I do not wish to see that occur. This proposed boat shed is an actual "home". The applicants have said that gray water, waste, etc will be held in tanks and emptied. But what safe guards or checks and balance will the ORC put in place to make sure these tanks are emptied in a timely manner and emptied safely?

This river mouth has such special character and much sea life; the sea life and it's safety is paramount over some advantages for tourists.

If the application is subject to limited notification, the consent authority may adopt an earlier closing date for submissions once the consent authority receives responses from all affected persons.

You must serve a copy of your submission on the applicant as soon as is reasonably practicable after you have served your submission on the consent authority.

**Privacy:** Please note that submissions are public. Your name and submission will be included in papers that are available to the media and the public, including publication on the Council website. Your submission will only be used for the purpose of the notified resource consent process
