#### 10.1. Director's Report on Progress

#### 1. Précis

This report records stakeholder engagement activity between 26 August 2017 and 29 September 2017.

#### 2. Implementation of Rural Water Quality

Our staff have undertaken engagement activities and events with a range of stakeholders under the council's rural water quality programme (W3). The specific objective for stakeholder engagement activity, as outlined in the 2017-18 Annual Plan, is to achieve 90 percent landholder awareness of the rules. This is measured using a stakeholder survey and was achieved at 91%.

#### 2.1. Field Days, Workshops, and Presentations

#### 2.1.1. Industry-led activities

#### i. Open Country Environmental and Sustainability Manager – 31 August

Liaison staff met with Craig Campbell from Open Country Dairy, which has supplier farms in South Otago. Craig has been appointed in the newly established role of Environmental and Sustainability Manager. The meeting was to familiarise Craig with the rural provisions in the Otago Water Plan and for Otago Regional Council to get an update on the direction of Open Country Dairy Environmental policy and operations.

#### ii. DairyNZ Envirowalk presentation – 6 September

Liaison and science team staff meet with staff from DairyNZ for a presentation on the newly developed Envirowalk application that has been developed for farmers to use. This will be a tool that staff can use to introduce landholders (elements are also relevant to other industry groups) to environmental best practise principles with the ability to populate a management plan after working through the process.

#### iii. South Otago Dairy Working Group – 19 September

Liaison and environmental monitoring staff met with the South Otago Dairy Working group (DairyNZ, Fonterra, Open Country, Federated Farmers, and Clutha Development Trust represented) for the first meeting of this milking season. The group was updated on the dairy programme for the year and a field trip for ORC monitoring and Liaison staff was planned with DairyNZ. The purpose of this event is for ORC staff to upskill in effluent management on farm and to learn about different effluent set ups and update on any technological advances in this area.

#### iv. North Otago Dairy Working Group – 21 September

Liaison staff met with the North Otago Dairy Working group (DairyNZ, Fonterra, Oceania Dairy, Federated Farmers, and North Otago Irrigation Company

represented) for the first meeting of this milking season. The group was updated on the dairy programme for the year. Chair of the Dairy Working Groups (both North and South Otago) Nicholas Tait of DairyNZ will be stepping down from the role and moving to Canterbury shortly. Trevor Gee (DairyNZ) will take over the role of Chair. Members of the group will work with NOSLaM to pull together an N-loss workshop for North Otago farmers in November.

#### 2.1.2. Community-led activity

#### i. River Estuary Care: Waikouaiti-Karitane Planting day – 16<sup>th</sup> September

Approximately 50 members of the community, including ORC liaison and communications staff, assisted with the planting of 555 native trees alongside the north branch of the Waikouaiti River on the property of David and Sarah Smith.

This initiative is part of the Ki uta ki tai volunteer programme which combines volunteers working with several East Otago community groups on environmental enhancement projects over the course of a long weekend, twice a year. ORC currently assists the River Estuary Care: Waikouaiti-Karitane group with their quarterly newsletter and assisting with the planting day assisted with building inter-organisational relationships as well as observing and supporting the riparian planting of significant area of agricultural land, a good land management practice.



#### ii. Tuapeka catchment meeting – 26th September

Liaison staff and Bill Fitzgerald who is a local contractor in the Lawrence area arranged a meeting on site in the Tuapeka catchment to discuss willow management and the effects of debris dams during the flood event in July. The meeting was also attended by operational engineering staff from the ORC, 12 farmers and a Federated Farmers representative. The farmers present represented all the farms holdings along the Tuapeka River and a good discussion resulted in a plan for manging willow in the area and agreement on how to manage priorities.



#### iii. North Otago Sustainable Land Management Society (NOSLaM): Kakanui Pod Group meeting – 7 September

Approximately 40 landowners from the Kakanui catchment attended a successful NOSLaM meeting held at the Five Forks Hall. ORC liaison staff presented as part of a group of 5 presenters. The purpose of the meeting was to introduce NOSLaM's new coordinator, details about the overall project and to provide landowners with background about why they need to be involved. It was great to see a number of landowners attending that do not usually get involved in this type of meeting. #### 2.2. Media and promotion for rural water programmes

#### 2.2.1. Irrigation NZ Magazine

The spring issue was published mid-September. Articles include a case study of irrigation in South Otago, updates on developing a plan change for residual flows, the Arrow River / Wakatipu Basin minimum flow consultations, and a general update on work ORC has been doing. The summer issue is currently being planned.

#### 2.2.2. Waterlines

The spring issue will be distributed in the first week of October. Articles include an update on the effectiveness of broom gall mite at two release sites, a flow-chart of ORC's enforcement process, a case study on good soil management, a reminder of the offal pit rules, a case study on irrigation in South Otago, an article about a dairy farm on the Taieri that hosted school students, an explanation of residual flows, and an overview of a community workshop to gather values about the Arrow River and aquifer. Planning for the summer issue is underway.

#### 2.2.3. 'Good Water in Otago – ORC's Facebook page

There are currently 634 'likes', and we post approximately twice a week. Total reach from 26 August to 28 September was 4629, which is a decrease of 12% on the last reporting period.

#### 2.2.4. On-Stream

The tenth issue was emailed to 383 subscribers on 20 September. It included a feature about a new app DairyNZ is launching called EnviroWalk, which helps farmers identify good management practices they could be adopting. Also featured were the regular summaries from the four liaison specialists.

#### 3. Water Management Groups

#### 3.1. Water and deemed permit renewal project

#### i. Water user group meetings

The following meetings with groups are scheduled:

#### ii. Fish protocol and fish surveys for tributaries with deemed permits

Recent work on this component of the project has concentrated on finalising the protocol, in preparation for sharing it with the community and consultants. This document is to assist with what information is required from completing a fish survey for a consent application. This document has been developed by ORC with input from Fish and Game, DOC, and Iwi.

#### iii. Preparation for Round three presentations

The presentation for the round three presentation to catchment groups is currently being prepared and will include the following topics:

- Outlining fish survey requirements per tributary (number of sites per tributary, quality of surveys, and potential Council involvement and assistance)
- Flows per tributary, availability, and method
- Group sharing of water within tributaries during lower flows
- The need to apply for section 417 easements where water is conveyed across neighbouring properties from the point of take.

#### 4. Enviroschools

As set out in the Annual Plan 2017-18, ORC provides the regional coordination of the Enviroschools programme in Otago.

#### 4.1. Collaborative projects

Otago Enviroschools is involved in two exciting collaborative projects:

 School heating and energy use: Over half of Otago schools use coal for heating. It is a complex and expensive process for them to move to more sustainable forms of energy. Enviroschools is leading a long-term project currently involving some Dunedin schools, the University of Otago, DCC, ORC, and the Ministry of Education. The University of Otago will undertake an initial stock-take of heating and energy use in schools. The aim is to identify a range of sustainable energy solutions that schools and communities can implement. This will be supported with the development of educational resources.

 Solar shelters: In conjunction with the International Science Festival, ORC, and the Otago Polytechnic, Enviroschools will run a competition open to secondary Enviroschools for students to design solar-powered charging units for bus shelters enabling people to charge their devices while waiting for a bus. This project involves developing learning resources to support students and teachers. Toimata, the Enviroschools national foundation, is contributing \$5000.00 to this project.

#### 4.2. School projects

Many Otago schools are involved in biodiversity projects. Opoho Primary School, in Dunedin, worked with Clare from Orokonui Ecosanctuary to assess the biodiversity in their school grounds and surrounding area. They found no lizards in the area and have been working hard to establish lizard friendly habitat. The students researched and designed the habitat, presented their design to the Board of Trustees, selected plants, sourced rocks and logs, and have been working with some parents over the last few weeks to build the habitat. They are hoping to attract the Southern Grass Skink and will keep monitoring the area. This project was supported by the Enviroschools Empowerment fund.

#### 4.3. Teacher workshop

Teachers from Central Otago and Queenstown Lakes District recently attended an Enviroschools workshop exploring ideas for teaching about climate change. Many teachers struggle to find ways to teach about climate change so students are empowered to take action on this issue. Students are very interested in climate change.

#### 4.4. Enviroschools census

We are undertaking a major evaluation project of all Enviroschools in New Zealand in term 4. This replicates a 2014 study. The 2014 data has been invaluable for understanding the sustainability work schools do and for developing the programme.

#### 4.5. Enviroschools Community Engagement

Enviroschools participated in a waste-free promotion at the Dunedin Farmers' Market on the 16th of September. It was a great opportunity to talk to people about the work of Enviroschools and we demonstrated how to make waxed sandwich wraps. St. Leonards Primary School joined us and sold sandwich wraps students had made and the school's cookbook. The recipes profile the vegetables grown in the school's garden and were all had to pass the 'student test' to be included.

#### 5. Public Transport

#### 5.1. Queenstown public transport service launch communications

We have engaged Scope Media, an agency local to the Queenstown area, to work with us on communications for lead-up to and launch of the Queenstown bus service. Working with Scope Media, we now have a communication strategy and plan in place.

The plan includes direct engagement and close coordination with key stakeholders (i.e. QLDC, NZTA and Queenstown Airport) and identified primary

audiences (including community associations, school boards, Chamber of Commerce, Destination Queenstown). Video will be central to the marketing communications, with an approach of using humour and working with local influencers to ensure wide reach via social media. GoCards will be widely distributed, including via social media based competitions. A high visibility launch event will provide a focal point for media.

#### 5.2. Bus service brand

As previously reported, a new name and identity for the ORC's bus services in Dunedin and Queenstown has been developed. This is intended to aid the visibility of our bus service. This will be particularly relevant in Queenstown where there are a range of buses operating for different transportation functions alongside our public transport network. It is now in final stages of legal due diligence. The intention is to launch the new name and brand with the Queenstown service, including some fully branded buses, and subsequently begin integrating it into the Dunedin service. Full integration across all communications collateral is planned for both services with the launch of the new ticketing system in March/April next year.

#### 5.3. Communicating route and timetable information

With the upcoming launch of the Queenstown service we're taking the opportunity to pilot a new approach for us to sharing route information in print collateral. Route maps will be shown on a fold out map. We have been seeking feedback and input on how we display information on printed material in the Dunedin service; trialling this approach in Queenstown will be a useful step towards determining the path forward for Dunedin.

Timetable information is also displayed on our new website in mobile friendly format for the Dunedin service; feedback on how this is displayed has been positive. The Queenstown timetables will soon be available on our website as well. The online format allows for timetable display for individual bus stops.

Journey Planner, powered by Google Transit, is also now available for the Dunedin service and allows bus users to enter departure point and destination and get recommendations for which service to use. This will also be available for the Queenstown service shortly. For the Queenstown service, bus users will also be able to access real time information on the location of their bus via the NZTA-developed Choice app, which is already available on Android and iOS.

#### 6. Environmental Operations

#### 6.1. Pollution guidebook

A guidebook to promote 'Only drain rain' and give information for households and businesses has been written and is in the design phase. It outlines common urban activities (both household and workplace) that can pollute waterways if they enable contaminants to go into storm water drains. This will be used Otago-wide and ORC communications staff are working closely with environmental monitoring staff and territorials, as well as Enviroschools. We have viewed the initial concepts and will have a first draft completed by the end of October.

#### 6.2. Wetlands brochure

A brochure outlining the importance of wetlands and is currently being designed by an external agency. This will be used by environmental monitoring staff, and liaison specialist staff. This is due to be complete mid-October.

#### 6.3. Dairy inspections

In light of the recent flooding, ORC liaison staff, communications staff, and environmental monitoring staff are working closely with dairy and farmer industry groups to ensure we do not start our annual dairy inspections until farmers are ready. They have given positive feedback about the approach ORC has taken. Inspections are due to commence soon in areas not affected by the floods.

#### 7. Engineering

An opportunity for amenity enhancement as part of the Forth St to Harbour stage of the Leith Flood Protection scheme has been identified; members of the Stakeholder Engagement team have been scoping the potential for community engagement around determining an approach to this.

#### 7.1. Wallabies

Liaison staff are continuing to promote ORC's wallaby biosecurity response at appropriate opportunities and asking for members of the public to report sightings. Due to demand we are getting a re-print of the wallaby ute guide, and will use this opportunity to update the map of sightings and killings so it's current.

#### 7.2. Rabbits

We are working closely with community organisations on the Otago Peninsula to develop educational information that will inform land owners about their rabbit management responsibilities, and what their management options are. This campaign will eventually be rolled out across Otago. Our first meeting with the community is expected to be held in October.

#### 7.3. Rooks

During spring ORC asks for the public's help to report sightings of rooks to us so we can control them, with the goal of eradicating them from Otago. Stakeholder engagement organised an advertising campaign in North and South Otago, and jointly-advertised in South Otago with Environment Southland, which shows the public our councils collaborate on common issues. We have also had media coverage alongside advertising.

#### 7.4. Whitebait

Whitebait season runs from 15 August to 30 November. Stakeholder Engagement staff have worked with Department of Conservation to clarify messages to the public, and this has resulted in significantly less queries to both DOC and ORC. We will continue to promote messages via our Facebook page until the end of November.

#### 8. General Public Awareness Activity

As set out in the 2017/18 annual plan, we are committed to promoting community knowledge and awareness of the council's activities, and encouraging community participation in both decision-making processes and projects that promote sustainable use of resources. The following outlines a range of activities that have been undertaken to support this target.

#### 8.1. General media

From 28 August to 2 October ORC distributed 15 media releases on bus service changes, World Rivers Day, World Car Free Day, the Upper Clutha water management project and lake snow. There were 144 media articles published in print.

#### 8.2. Website redevelopment project

Our website redevelopment project started in February. The information below takes us through the phases we have followed throughout the project.

#### Phase 1:

Prior to starting our redesign and build of the new website we wished to obtain a deeper understanding of - how will the new website will help achieve organisation goals and objectives, who are our users and what does a great website look like for them, and what is working well with the current website.

To achieve these objectives the following research activities were completed:

- Document Review
- Google analytics review
- Stakeholder interviews
- Proto-personas exercise
- Website user survey
- Other Regional Council website reviews.

#### Phase 2:

This phase was to understand the objectives, challenges and develop a highlevel strategy, it included:

- Undertaking a high-level audit of the existing content
- Understanding and validating the users, their unique needs and motivations
- Identifying and agreeing on key sections/pages within the website that required the most attention.

The outcome of this phase was digital strategy document and a website requirements document.

#### Phase 3:

This was the 'define' phase which starts to outline the structure and functional design of the website. The following activities were completed:

- Three information architecture (IA) models were created and tested with key stakeholders
- User/client feedback was incorporated into the IA/functional design
- A visual design brief was created.

The outcome of this phase was an agreed IA and visual design brief.

#### Phase 4:

This phase was about applying a look and feel to our website and designing key visual cues that result in a positive user experience. Key activities of this phase were:

- Developing the overarching design approach to set the direct this was applied to number of key pages across desktop and mobile formats
- Designs were presented to stakeholders for feedback.

The outcome of this phase was the agreed website design.

#### Phase 5 (Current phase):

This phase brings the design to life on the web.

Our preview website was turned on for the public on September 4 to allow people to view and provide feedback. On September 18 the preview website was switched to become our current website <u>www.orc.govt.nz</u> with the old ORC website still available at <u>http://archive.orc.govt.nz</u>.

While the new website is live we are still working on putting content into it. The public are aware of this and they can link back to the old website at any time as well as providing us with feedback on the new site. The new website is now:

- Responsive, this means it will be easy to use on mobile devices
- Easier to navigate
- Easier to view alerts, whether it be a Bus alert, Civil Defence alert or River/Rainfall alert.
- Easier and more intuitive to search.

#### 8.3. Websites

There have been 25,570 visits to the new ORC website since launch on 18 September.

#### ii. www.lawa.org.nz


There have been 626 visits to the Otago section of the LAWA website, up 160% on the same time last year.
