1. Oceana Gold (New Zealand) Limited (**OceanaGold**) wishes to be a party to the following proceedings:
Cain Whanau v Otago Regional Council (ENV-2024-CHC-30).
2. OceanaGold made a submission on the subject matter of the proceedings.
3. OceanaGold is not a trade competitor for the purposes of section 308C or 308CA of the Act.
4. OceanaGold is interested in the parts of the proceeding which relate to the following particular issues:
 - a. MW-P4 and any other provisions in the PORPS that may directly or indirectly restrict owners of Māori land from being able to utilise their land; and
 - b. ECO-P1 to ECO P12 and inserting a new policy.
5. OceanaGold does not oppose providing specific provisions on utilising Māori land, however OceanaGold would object to any consequential changes to provisions which:
 - a. Results in the PORPS not giving effect to the National Policy Statement for Indigenous Biodiversity or any other National Policy Statement; or
 - b. Altering the consenting pathway for mining which was inserted into the ECO provisions.
6. OceanaGold agrees to participate in mediation or other alternative dispute resolution of the proceedings.
