- 1 On 22 April 2024, Oceana Gold (New Zealand) Ltd (**Oceana Gold**) lodged a notice of appeal in the High Court against the decision of the Respondent to accept the Freshwater Hearing Panel's recommendations in relation to a number of policies of the freshwater planning instrument parts of the Proposed Otago Regional Policy Statement 2021 (**PORPS**), including:
 - (a) LF-WAI-P1; and
