 - (b) HAZ-NH-P1A, HAZ-NH-P1, HAZ-NH-P2 and HAZ-NH-P10 and agrees that coastal hazards risk should be assessed and managed through the PORPS 2021; and
 - (c) UFD-P4 and agrees that when considering urban expansion the effects on degraded water bodies should be considered with regard to increased water supply, wastewater and stormwater.
