 Otago Fish and Game Council and the Central South Island Fish and Game Council (the Appellants) have filed a notice of appeal to the High Court against the decisions of the Otago Regional Council (the Respondent) on the Freshwater Planning Instrument parts of the Proposed Otago Regional Policy Statement (pORPS), upon the grounds that the Respondent made errors of law.

- Beef + Lamb New Zealand Limited (B+LNZ) lodged a submission to the Freshwater Hearings Panel which made recommendations on the pORPS to the Respondent.<sup>1</sup> The Respondent accepted those recommendations.
