MEMORANDUM SEEKING LEAVE TO ATTEND MEDIATION REMOTELY

27 November 2024

TO: The Commissioner Environment Court CHRISTCHURCH

- I refer to the Commissioner's direction dated 29 October 2024 that parties need to seek leave to attend Proposed Otago Regional Policy Statement mediations remotely.
- 2. The Environmental Defence Society (**EDS**) attended mediation on Group 3 (integrated management) on 12 and 13 November 2024 in person. It is a party to mediation on Group 5 (land, freshwater and soil) which is scheduled for 3, 4, 5 and 6 December 2024.
- 3. Due to resourcing constraints, EDS is unable to attend mediation on Group 5 in person and seeks leave to attend remotely. With respect to its interest in the topic:
 - (a) EDS has one appeal point concerning LF-LS-P16A Managing pests. EDS seeks amendments to the policy so that new plantation forests in or adjacent to high value landscape, coastal or indigenous biodiversity areas do not consist of wilding conifer species and that the policy should include direction to eliminate (not just control) pests.
 - (b) EDS is listed as a section 274 party to other appeal points covered in Group 5, however its interest is limited and is supportive of Council's position.
- 4. While EDS acknowledges the value of in-person attendance, on this occasion it is unable to make the necessary arrangements. I note that Forest & Bird seeks the same relief as EDS in relation to LF-LS-P16A and that Mr Anderson will be appearing for Forest & Bird at the Group 5 mediation in person. EDS's position is aligned with that of Forest & Bird on this point.
- On that basis, EDS respectfully requests leave to attend Group 5 mediation remotely via AVL.
