

Te Rūnanga o Moeraki, Kāti Huirapa Rūnaka ki Puketeraki, Te Rūnanga o Ōtākou and Hokonui Rūnanga (collectively, “**Kāi Tahu ki Otago**” or “**Kā Rūnaka**”); Te Ao Marama Incorporated on behalf of Waihopai Rūnaka, Te Rūnanga o Ōraka Aparima, and Te Rūnanga o Awarua (collectively, “**Ngāi Tahu ki Murihiku**”); and Te Rūnanga o Ngāi Tahu, together referred to as “**Kāi Tahu**”, hereby give notice that they intend to appear and be heard on an appeal by the Appellants, Otago Fish and Game Council and Central South Island Fish and Game Council, against the decisions of the Otago Regional Council (“**ORC**”) on the freshwater planning instrument parts of the Proposed Otago Regional Policy Statement 2021 (“**PORPS**”), which were made on 27 March 2024 and publicly notified on 30 March 2024 (“**Decisions**”), pursuant to cl 56 of Schedule 1 to the Resource Management Act 1991 (“**RMA**”).
2. Kāi Tahu made a submission on those parts of the PORPS which are appealed by the Appellants. Kāi Tahu received notice of the Appellants’ appeal on 24 April 2024.
