1 **TAKE NOTICE** that Oceana Gold (New Zealand) Limited (**OGNZL**) would like to appear and be heard on the appeal of the freshwater planning instrument provisions of the Proposed Otago Regional Policy Statement (**PORPS**) by Te Rūnanga o Moeraki, Kāti Huirapa Rūnaka ki Puketeraki, Te Rūnanga o Ōtākou and Hokonui Rūnanga, Te Ao Marama Incorporated on behalf of Waihopai Rūnaka, Te Rūnanga o Ōraka Aparima, and Te Rūnanga o Awarua and Te Rūnanga o Ngāi Tahu.

Upon the grounds:

- A: OGNZL submitted on the freshwater planning instrument provisions of the PORPS which are the subject of the proceedings.
