Royal Forest and Bird Protection Society of New Zealand Incorporated (Forest & Bird) v Otago Regional Council (ENV-2024-CHC-26) being an appeal against decisions of Otago Regional Council (Respondent) in relation to the non-freshwater parts of the Proposed Otago Regional Policy Statement 2021 (PORPS) (Appeal).
